# **POLICY:**

**Concussion Policy** 

Athletic Director, John Rosa reviewed with the board a Draft Student-Athlete Concussion Policy saying that if a student suffers concussion like symptoms the student will not be cleared to return to the sport unless cleared by a medical professional. All district coaches, including volunteers, will be required to take the online concussion-training course each year (on or after July 1) PRIOR to the official start of their season. The policy will apply to all students participating in district sponsored inter-scholastic sports (including cheerleading) grades 7 – 12. The policy, which is in compliance with Senate Bill 200, is designed to establish standards for managing concussions and traumatic brain injuries to student athletes. (Handout)
