- B. Reviewed initial outcomes of the joint Conway Borough-School District Crows Run Corridor Road Project saying a community meeting was held on Monday, November 21, 2011. As a result, a committee will be formed to continue ongoing discussion that can be submitted to Local Representatives. Mrs. Heyman, Board Member, commented that there wasn't any money currently allocated in the State Budget for Crows Run. No immediate positive outcome resulted but momentum has been started.
