# **COMMUNICATIONS:**

Donations

Dr. Jeff Fuller, Superintendent, advised the Board that the High School is in receipt of donations totaling \$2,000 from seven local contributors in support of the High School's effort to form a "National Archery in the Schools Program". Mr. Bert Pickard is actively seeking funding and has raised over \$2,000 to date from multiple donations.

# **PUBLIC/COMMUNITY RELATIONS:**

Roy Whipple, Freedom, asked for an explanation of the Common Core Curriculum and how it was being mandated by the state taking away local control. Dr. Jeffrey Fuller, Superintendent, responded saying the PA Common Core State Standards (PACCS) clearly communicates what is expected of students at each grade level. This will allow our teachers to be better equipped to know exactly what they need to help students learn and establish individualized benchmarks for them. The Common Core State Standards focus on core conceptual understandings and procedures starting in the early grades, enabling teachers to take the time needed to teach core concepts and procedures well and to give students the opportunity to master them.

While the PA Common Core Standards have been adopted by the Pennsylvania Department of Education, we have been working with our professional staff to create instructional objectives that are based on the PACCS, but are appropriate to the Freedom Community. The PACCS are the minimum requirements, but districts are permitted to go beyond the standards.

Andy Yeck, New Sewickley Township, represented the football team to express their opinion as to what they would like to see happen in replacing the football coach vacancy. Mr. Yeck said the team is not sure why change is necessary and presented to the Board a letter signed by the team requesting the same coaching staff be retained.

#### SUPERINTENDENT'S REPORT:

Dr. Jeffrey Fuller, Superintendent, reported on the following:

Dr. Fuller reported Governor Corbett presented his proposed budget to the joint legislature on February 6th. His proposal did not appear to receive broad support, even from his own party members in the legislature. Governor Corbett is proposing what he referred to as "Record Funding for Education" as part of his budget proposal for the new fiscal year. This includes approximately \$100 million in additional funding for K-12 schools.

Additional funding comes in the form of an added \$96 multiplied by our Weighted Average Daily Membership multiplied by our Aid Ratio, which nets an approximate proposed increase of \$98,620. However, the proposed budget also includes a proposed shortfall of \$100 million in the state's contribution to the Retirement system, meaning, in our opinion, that if the proposed changes to the retirement system are not enacted, the \$100 million budgeted for K-12 educational programs will be redirected to the retirement system.

The Governor has also proposed selling the state-controlled liquor stores and using the \$1.01 billion in proceeds to fund a block grant program. The program would be funded for a period of four years, when the funds would be completely expended. School districts would be able to apply for funding in four areas:

- Pre-K programming
- Individualized Instruction
- STEM-related programs for students in grades 6-12
- School Safety

Also, although the Governor's proposed budget did not address the issue of funding for Charter Schools, there was some positive news for traditional public schools from Harrisburg regarding Charter Schools over the last few weeks. When the initial achievement results came out in the fall, many educators felt that the scores for both brick-and-mortar and cyber charter schools were inflated. This led to a number of questions being raised that made it to the US Department of Education. Based on a directive from the US Department of Education, PDE was required to recalculate the achievement rates for all charter schools in the state. Not surprisingly, they found that 21% fewer Charter Schools - including both brick-and-morter and cyber charters - made Adequate Yearly Progress. In fact, not one of the eight-cyber charter schools operating in the state achieved AYP and six of the eight are in Corrective Action II, meaning that they have not made Adequate Yearly Progress in at least six years.

While this is not good news for our students who attend a charter school, it continues to point to the fact that the Freedom Area School District really is the best choice in public education for the students in our community.

Report

Building & Grounds Gary Mortimer, Director, Buildings & Grounds, gave the following monthly report: General: All school generators have been serviced and tested; our insurance company has inspected all boilers and air tanks. Recommended repairs, which are minor, are being completed. Costs of materials are less than \$2000.

> Big Knob: Completed were: A water leak repair on the HVAC hot water supply line to the roof top unit (reset boiler pumps and domestic water pumps); Damage repaired to the walls and ceiling tiles due to the water leak; Sewer plant repairs on pump controller. We received a letter confirming two violations of the sewer plant, awaiting recommendation from DEP.

Conway: General repairs.

High School: Replacement of a gas valve on Renzor air unit A for girls' locker room on the pool section; Replacement of the ignition control with a new sparker on Renzor air unit B for boys' locker room on the pool section; Rooftop units 12, 3, A, were repaired with various parts; Failure of control system on 1/6/13, system running on old GCM controls with no available way to adjust temperature/operation times.

Middle School: Replacement of six univent motors completed; Elevator inspection was completed by the Department of Labor and Industry, one deficiency was discovered, code 114, no telephone or elevator gong available, bids are being accepted to meet current codes.

The boiler control board system has failed, heat operation is being manually controlled while bids are received.
