- 1) Fall Seasons updates for Football, Boys Soccer, Girls Soccer, Golf, Volleyball, Cross Country
- 2) Code of Conduct forms are being signed and collected. Coaches are asked to continue to remind players to turn them in. Starting with the winter season, this form will be a part of the athletic paperwork that will need to be submitted prior to the start of the season.

This will greatly improve communication between everyone. There are only a few weeks left in the fall season, so these teams won't benefit as much, but moving forward this will be in place.

We are currently looking at ways to avoid power issues for the last football game(s). We may need to have discussion about running the temporary concession stand from a generator.

Gary Mortimer, Director of Buildings & Grounds, provided the following monthly report:

**High School:** Boiler inspections, along with any pressurized vessels, were inspected on September 24th by Travelers Insurance. After completing the inspection with Mr. Fischer, one item needed attention. The sight glass on the kitchen steamer dripped and needed adjusted and tightened. All boilers and air tanks passed.

The roof repairs have been started by Triangle Roofing Inc.

**Middle School:** Work has been completed on the Trane chiller. New unloaders, with an upgraded bypass, have been installed on both compressors.

The equipment filters/fall maintenance has started and has been 40% completed.

**Big Knob:** Rooftop HVAC equipment has been serviced for fall, along with the exhaust fans. We have experienced low water on September 15th and the 25th. We purchased water both days to operate the school. The pump system has been checked.

The boiler pressure relief valve has been replaced on one of the domestic hot water boilers.

**Conway:** Work continues with the pneumatic controls on the heating systems. Exhaust fans have been serviced for the fall. General plumbing repairs.
