Budget 2012/13

High School Schedule Tim Dadich, High School Principal, discussed adjustments to the High School

Daily Schedule saying that he is recommending the changes due to the down time

between classes. Five minutes will be allotted for class changes. In addition, an Academic Assistance 30 minute period will be added at the end of the day for students to have access to all of their teachers for the support of the school curriculum. The program provides a time for teachers to identify and work with students with documented learning differences to assist them in reaching their highest potential within the rigorous academic environment at Freedom High School.

Class detentions will occur on Saturdays and will be monitored by Principal Dadich, accommodations will be made for transportation.

The RISE Program will be provided to any student who displays habitually negative behavior that goes against our expectations for student conduct. Those students will be recommended to the RISE program. Teachers recommending a student for the program must have already made contact with the student's parents or legal guardian, as well a demonstration that he/she has made use of multiple strategies to work with the student to rectify the undesired behaviors. The program is being implemented to ensure that students feel safe and are getting an education. The RISE program requires immediate action from teachers.

Parents will be advised through the student handbook and the District Website of the programs being implemented.

The Middle school will implement a similar program titled "Restoring Individual Student Success". Copies of both programs are attached to the minutes in the minute book.
