Gary Mortimer, Buildings and Grounds Director, gave the following monthly report:

## Monthly Summary:

- Conway school update: Plumbing repairs to a leaking Sloan valve were completed by replacing the faulty unit and testing the operation. In addition, two of the room uni-vent heaters used to maintain the heating operation were repaired. Weekly checks and service to maintain the system continue with the boiler and pneumatic systems.
- Approximately two tons of JASA was purchased to repair the blacktop area in front of the High School. The remaining JASA has been covered for future pot-hole repairs in the spring.
- The High School had several mechanical repairs completed in the past month. We experienced fan, burner motor, and electrical component failures on several roof top units. The gas train was replaced on one of our makeup air units for the locker room. Currently we have one makeup system for the kitchen ventilation system off line. Smoke detector parts have been ordered and shall be installed on the 20th of February.
- In the Elementary building, repairs were completed on two different water closets. Upon a fire drill test we discovered the master fire panel was not communicating with the Middle School sub panel. The panels should notify both buildings upon a fault in either
building. The contractor has been called to test the sub panel since we have verified communication with the main panel.
- General repairs regarding the Middle School classroom uni-vents were completed. We replaced two hot water control valves along with work on the pneumatic system for proper operation. Replacement of one emergency pull station for the fire alarm system was completed. We have scheduled the replacement of two backflow preventers on February $20^{\text {th }}$ to be installed and certified by a third party.
