Policy No 123.1

John Rosa, Athletic Director reviewed New Policy No. 123.1, Concussion Management, and Administrative Guidelines 123.1-AR.0, Sports-Related Concussion/Mild Traumatic Brain Injury saying it was modeled after the recommended PSBA policy and assured the board it met Freedom Criteria. The policy adheres to SB 200 – Policy does not include baseline testing. Rosa said the guidelines need to be followed and that he will hold informational meetings with parents and children – need to partner with parents. Solicitor to review.
