Gary Mortimer, Director of Buildings & Grounds, provided the following monthly report: **Monthly Summary:**

- Installation of a new concrete sidewalk with sealer has been completed at the High School. This new extension will provide access from the crosswalk over to the gymnasium entrance.
- Additional concrete pads are being installed to provide a playing area located by the first wing playground. In addition, a new concrete slab will be installed by the gate on 8th Avenue for a future ticket booth.
- Concrete repairs and additions will be occurring in front of the Middle School with the sidewalk and curb area.
- Benches and tables from Conway and Big Knob have been installed at the Elementary School playground. We modified the storm drains inside the playground area with a protective rubber matting and additional single cut mulch was installed.

- Exterior building and parking lot lights were repaired on campus.
- Serviced the Power Flame burners on both Middle School boiler systems along with the pumps and actuators.

FACILITIES MASTER PLAN:

In the absence of Scott Smith, Construction Representative, Dr. Jeff Fuller, Superintendent, gave a construction progress update saying we are now down to 8-9 items on the punch list. In addition, an on-line auction has been held for unusable items to the district for the Big Knob property. A second on-line auction will take place next week for the Conway Building. Several entities are interested in purchasing both buildings. At this time the District will hold on to the Big Knob property in the event there is growth in New Sewickley Township.
