# **SUPERINTENDENT'S REPORT:**

Dr. Fuller, Superintendent, provided the following information:

- Family Behavioral Resources Presentation Joe Testa, School Psychologist, introduced Susan Battista, Director, Business Development, and Andrea Morrison, Clinical Supervisor, from Family Behavioral Resources, provider of Site-Based Mental Health Services that could be offered to district students in need. They provided a high level overview of their organization saying they currently have 950 employees and have served 8,000 consumers. Their Mission exists to bring services to individuals who need them in their natural setting. If contracted, the District would only need to provide a room to access the services.
- ➤ <u>In-Service Day Review</u> Dr. Fuller reviewed the first in-service for the 2016/2017 school year to include the new math series, crisis prevention training, presentation on accessing data and what the numbers say about our students.

Gary Mortimer, Director of Buildings and Grounds provided the following monthly report: **Monthly Summary:** 

- A 3rd party inspection of the Middle School boiler systems has been completed. This is required by our insurance company. Both domestic hot water boilers as well as the hydronic heating boilers were inspected. The inspection required opening the boilers to complete an internal inspection of the radiant tubes and sections. No additional action required due to the inspection.
- On October 28<sup>th</sup>, a full load safety test per code with the Middle School Elevator will be completed. This test is required every five years along with the three year Hydraulic pressure relief test. Annual inspections will also be completed at all buildings.
- We have fabricated and installed an intake fan with thermostat at the Middle School transformer room. The new step down transformer is now air cooled not oil filled and requires ventilation for better operation. The fan will operate when temperatures exceed the room thermostat in warmer temperatures.
- On October 31<sup>st</sup> an inspection of the fire suppression system will be completed. The annual inspection of the domestic water back flow preventers and check valves in all schools will be tested. Report to follow.

• New 2017 Ford Transit van (10 Passenger) has arrived. The van has been lettered and properly equipped with the required items for transportation of students.

### **FACILITIES MASTER PLAN:**
